Pioneering events and networking

The Government of the Future Summit

Bringing together senior government executives and policy experts to collaborate and engage, the annual summit aims to raise awareness of the

need for and benefits of state transformation. It showcases state transformation success stories and sets out concrete strategies and solutions to shape the government of the future.

The 2011 Government of the Future Summit takes place on 17th May at the Résidence Palace, International Press Centre, Brussels. The theme for the event is Leading Public Sector Innovation: Modernising the State for the Post-Crisis World and focuses on innovation as a catalyst for public service organisations. Keynote speakers include the Prime Minister of Luxembourg and President of the Eurogroup, Jean-Claude Juncker. As the flagship event of the Government of the Future Centre, the summit brings together key policy makers, public managers and other senior representatives from European governments to rethink policies, reshape delivery mechanisms, and restructure public services. This year's summit also serves as a platform to launch the 2011 Government of the Future Report, “Innovation in Europe: The role of government as a catalyst for change.” The next generation of public service leaders will be given a chance to demonstrate their thought leadership as the student teams from the College of Europe present the findings of their state transformation case studies to the attendees.

More than 120 people attended the first annual Government of the Future summit in June 2010 attracting senior government leaders and policy makers.

High-Level Roundtables for Government Executives

The Government of the Future Centre runs a series of senior level roundtables to explore the challenges, opportunities and solutions around some of the hot topics facing public service organisations. The roundtables bring together prominent keynote speakers, public service organisation leaders, subject-matter experts and public figureheads within their respective fields for debate and networking on core topics of the day, with the ultimate goal of sharing leading ideas and solutions to improve public service delivery across Europe.

In the Spring of 2011, the programme of roundtables includes:

Sustainable Public Finances: 22 March 2011

Keynote speaker:

Marco Buti, Director-General, DG Economic and Financial Affairs, European Commission.

Discussion topic:

With most European Union member states facing long term structural budget deficits, achieving sustainable public finance has become increasingly complex. The roundtable will examine the challenge of repairing public finances, reducing operating costs while increasing revenue yield for government tax and revenue agencies.

Employment and Skills: 29 March 2011

Keynote speaker:

Xavier Prats-Monné, Deputy Director-General, DG Education and Culture, European Commission.

Discussion topic:

Unemployment rates are at record levels across the Eurozone. Governments currently face new and increased labour market difficulties, combined with a growing skills gap. This roundtable will examine the challenges and highlight how innovative approaches can help to get people back to work, such as improving the efficiency of employment agencies and up-skilling the future workforce.

Public Procurement: 04 May 2011

Keynote speaker:

Jonathan Faull, Director-General, DG Internal Market and Services, European Commission.

Discussion topic:

With the current pressure on public finances, there is a promising opportunity to streamline and innovate procurement operating models across the European Union. This roundtable explores challenges in public procurement procedures, examines solutions and highlights leading practices — across the European Union single market, at national level and within key sectors of the economy.

Groundbreaking research and thought leadership

International benchmarks

Drawn across public sector entities and aimed at the operational or agency level, the benchmarks position public sector organisations against the operational performance of their peers across Europe. The Government of the Future Centre's series of benchmarks compare statistics on employment, welfare, health and public finance. Combined with the findings from the case studies on European Union and international leading practices, these benchmarks will shape and inform the conversations at forthcoming policy roundtables and the annual summit and provide a valuable resource for public agencies around Europe.

Groundbreaking research

The Centre has launched a groundbreaking study on the role of innovation in reviving the public sector. The study assesses the role of innovation at an organisational level to improve operational efficiency and effectiveness and, with respect to policy, to promote innovation in the economy. The report argues that government needs to do more to become an engine for innovation and growth for their economies. The focus will be on identifying the strategies governments should take to catalyze growth opportunities, drawing on macro-economic modelling by Oxford Economics. The research includes qualitative interviews with senior government practitioners and academics, and in-depth case studies from innovation leaders to illustrate specific strategies and initiatives.

State transformation case studies

Students of the College of Europe research public service organisations, evaluate their challenges and recommend solutions, guided by Accenture state transformation practitioners. The case studies present a unique opportunity for tomorrow's public service leaders to gain practical experience in the issues faced by public service organisations, and for these organisations to benefit from the innovative, fresh thinking of the next generation of public service leaders.

Four case studies on state transformation that evaluate the challenges of a state agency and recommend solutions are presented annually. The topics include:

Benefits system: Italian Social Security Institute (INPS)

"Shock absorbers" were widely extended by the INPS after the financial crisis and their application across Italy needs reassessment. The students must outline how best to reform the link between passive and active labour market policies, taking into consideration budgetary restrictions, the political pressures of stakeholders and national/regional dependencies.

Health: Valencia's Regional Health Authority

Valencia's health provision is immersed in a new social environment that requires an increase in productivity and efficiency. The students involved in this case study are defining new organisational and collaboration models within the budgetary and political restrictions of the public sector, particularly focused on identifying innovations and leading practices in public-private healthcare management.

Sustainable public finances: Norwegian Tax Administration

A case study that investigates how revenue departments regulate and respond to international activities. Some of the challenges that face the students in assessing this topic include cross-border tax regimes, incompatible technologies and corporate resistance to information sharing.

Welfare: Belgium Federal Public Service Social Security

The students are tasked with outlining a strategy for the Federal Public Service in facing the challenge of an aging population. The case study will include the definition of a new business model that combines efficiency targets with ecological demands, and proposals for setting up a new knowledge management system.
