# Top Policymakers Launch Growth Initiatives at Europe 2020 Summit

The Europe 2020 Summit convened under the timely theme of Unleashing Growth and Creating Jobs. Throughout the one-day summit, organised in collaboration with the Danish EU Presidency, high-level participants debated proposals that included not only ritual appeals for more growth, but also contained policies capable of delivering it. José Manuel Barroso, president of the European Commission, launched the debate with a blistering keynote. Then three Europe ministers – David Lidington (UK), Enzo Moavero Milanesi (Italy) and Nicolai Wammen (Denmark) – presented their governments' ideas on growth (Messieurs Lidington and Moavereo Milanesi led a joint session to present their governments' "growth" letter to the European Council). Earlier, Yannis Stournaras, general director of the Foundation for Economic and Industrial Research, made a forceful call to keep Greece in the eurozone (Mr. Stournaras was appointed finance minister of Greece in the June government reshuffle). Beñat Bilbao-Osorio, associate director of the Centre for Global Competitiveness and Performance at the World Economic Forum; Alessandro Leipold, chief economist of the Lisbon Council and former acting director for policy studies in the economics department of the OECD; and Lucio Vinhas de Souza, managing director and





sovereign chief economist at Moody's Investors Service, also joined the rich panel discussions. # European Centre for Government Transformation: A Banner Year Completed

In June, the European Centre for Government Transformation, a joint venture of the Lisbon Council, the College of Europe and Accenture, completed its third banner year, which culminated in The 2012 European Summit for Government Transformation, a highlevel summit for top state transformation agents. Helle Thorning-Schmidt, prime minister of Denmark and head of the Presidency of the Council of the European Union, delivered The 2012 Jean Monnet Lecture – and handed the Public Service Innovation Award to a team of College of Europe students who participated in the 2012 state

transformation case study competition (this year, the winners were the employment team, which prepared a case study on sustainable employment strategies at the *Bundesagentur für Arbeit* in Germany). Robert-Jan Smits, director-general for research and innovation, also delivered an overview of European Commission actions on public-sector innovation, and Ben Page, CEO of Ipsos MORI, presented a new study on *Leveraging Growth through New Approaches for Government*. In the run up to the Summit, the European Centre for Government Transformation convened three thematic high-level roundtables: digital government, employment and sustainable public finances. ### Gan Zhao Li: New Centre on Sino-European Relations and Innovation

The Lisbon Council launched a new centre of excellence: the **Gan Zhao Li Centre**, which will explore innovation through a Sino-European perspective. The three Chinese characters in the name mean "power to inspire." The work of the centre got off to a promising start with a **High-Level Working Group on Innovation and Growth: Understanding China's Market and Management Education System**. Prof. John Quelch, distinguished professor of international management, vice-president and dean of the China-Europe International Business School (CEIBS) in Shanghai, delivered a forceful presentation to senior diplomats and innovation experts. In 2012, the initiative will be led by Martin Schuurmans, senior adviser for innovation and entrepreneurship at the Lisbon Council and founding chairman

of the European Institute of Innovation and Technology (EIT), and Paul Hofheinz, president of the Lisbon Council. Graham Watson, member of the European Parliament, president of the European Liberal Democrat and Reform Party and member of the EP delegation for relations with People's Republic of China, will serve as co-chair. ### Commissioner Malmström Keynotes High-Level Roundtable on Internal Security

Cecilia Malmström, European commissioner for home affairs, keynoted a **High-Level Roundtable on Internal Security**. With concern over immigration and terrorism mounting, the discussion focused on how digital technologies and modern communication systems can lead to better-managed, more secure organisation of interior policy. In times of budgetary constraints, special emphasis was placed on smart and cost-efficient solutions, building on existing European networks and collaborations. At the heart of the debate was the issue of how to treat third-country nationals, making legal access easier and more expedient – especially important in the inter-connected world of today where seasoned professionals move in and out of places to fulfil special assignments. The reality of 27 different systems can be a stumbling block to facilitate movement of people, creating legal uncertainties and causing redtape for all parties involved. There was consensus among participants that vast improvements to the current system are possible, yielding untold benefits for citizens and ultimately leaving Europe and Europeans more secure.

Lisbon Council principals kept very busy in the first half of 2012. Tjark de Lange, co-founder and treasurer, received the Order of Oranje-Nassau for his career as a successful entrepreneur.
