

### The Rise of the Micro-Multinational: New Publication

Ann Mettler, executive director, and Anthony D. Williams, senior fellow for innovation, concluded a year-long research project — which included a study visit to Silicon Valley — with the publication of a major new paper: The Rise of the Micro-Multinational: How Freelancers and Technology-Savvy Start-Ups are Driving Growth, Jobs and Innovation. The authors explain how technology has enabled small companies to compete on a global scale, and discuss the implications for competitiveness, value creation and traditional models of employment. The paper sets out a nine-point set of recommendations for policy makers to create jobs and lay a foundation for future prosperity in Europe and North America. The Lisbon Council took a leading role in the first **Innovation Convention**, the European Union's flagship innovation event, led by José Manuel Barroso, president of the European Commission, and Máire Geoghegan-Quinn, European research, innovation and science commissioner. Ann Mettler, executive director, opened the conference introducing President Barroso and facilitating the opening plenary session. She also chaired a special plenary session

with Eric Schmidt, executive chairman of Google. In addition, the Lisbon Council convened an oversubscribed fringe event in the margins of the Innovation Convention, where leading thinkers discussed and debated *The Rise of the Micro-Multinational: How Freelancers and Technology Savvy Start-Ups are Driving Innovation.* Don Tapscott, award-winning co-author of *Wikinomics: How Mass Collaboration Changes Everything*, who was recently chosen by Harvard Business Review as one of the top 10 business thinkers in the world, keynoted the session. Fabien Curto Millet, senior economist at Google, also joined the debate.
