Description: Cookie generated by applications based on the PHP language. This is a general purpose identifier used to maintain user session variables. It is normally a random generated number.

cb-enabled

__utmc

Description: This cookie is associated with a free script which shows a cookie alert notice on a website. It is used to record when the user has dismissed the notice to prevent it reappearing on return visits.

_utma
Description: Used to distinguish users and sessions. The cookie is created when the
evascript library executes and no existingutma cookies exists. The cookie is updated very time data is sent to Google Analytics.
_utmb Description: Used to determine new sessions/visits. The cookie is created when the
avascript library executes and no existingutmb cookies exists. The cookie is updated very time data is sent to Google Analytics.

Description: Not used in ga.js. Set for interoperability with urchin.js. Historically, this cookie operated in conjunction with the __utmb cookie to determine whether the user was in a new session/visit.

utmt

Description: Used to throttle request rate.

utmz

Description: Stores the traffic source or campaign that explains how the user reached your site. The cookie is created when the javascript library executes and is updated every time data is sent to Google Analytics.
