An SME Agenda for the 21st Century



Consultants often say, "if you want to change something, figure out how to measure it." It is in that spirit that the Lisbon Council launched The 2021 Green, Digital and Competitive SME Index, a comprehensive catalogue of 33 indicators which ranks and measures progress on Europe's flagship initiatives: the green and digital transition.

Context is King: How Correct Data Can Lead to False Conclusions

On 12 October 2021, in a now infamous Joe Rogan Podcast anti-vaxxer Alex Berenson said that "the vast majority of people in Britain who died in September were fully vaccinated," offering this dubious fact to support his view that COVID-19 vaccines were as dangerous as the virus itself. The statement, while formally correct and based on official data from the United Kingdom National Health Service, was highly misleading: it missed the crucial context that the vast majority of the British population was vaccinated so of course the vast majority who died was vaccinated as well. In fact, the mortality rate of the unvaccinated population – seen in the right context – was several times higher than the

Barcelona, Brussels Capital Region, Espoo, Ghent, Glasgow, Gothenburg, Helsinki, Kyiv, Lisbon, Ljubljana, Madrid, Mataró, Milan, Murcia, Paris, Porto, Rotterdam and

Tallinn take an active role in this high-powered, deep-dive on the cutting-edge of digital government and local-service delivery [Catalonia Region (Spain), Kronoberg Region (Sweden), Emilia-Romagna Region (Italy), IE Center for C-Centricity (Spain), VTT Technical Research Centre (Finland), Eurocities and the Lisbon Council are also partners]. The three-year project, co-funded by the European Union, will define and benchmark best practice in digital-service delivery in a series of policy briefs and summits, including a constantly updated performance dashboard and a cutting-edge User-Centric Services Repository. More recently, the consortium asked 35 cities and departments to present their most user-centric digital-government projects to be evaluated by an Expert Jury as part of The 2022 UserCentriCities Award. Lisbon Council and more, takes a three-year look at the power and potential of cross-border digital services – and the challenge of delivering them seamlessly and effectively across borders.
